Porta Communications PLC (LON:PTCM), the international communications and marketing group, has formally implemented the revolving credit facility with Clydesdale Bank.

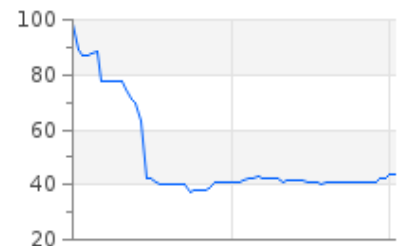
All of the conditions of the facility, details of which were disclosed last week, have now been met and the company can start drawing down money from the facility.
