Proactive news snapshot: Bluerock Diamonds, Highland Natural Resources, AppScatter...

BlueRock Diamonds PLC (LON:BRD) has completed a crushing circuit upgrade at its Kareevlei mine in Kimberley, South Africa.

Highlands Natural Resources PLC (LON:HNR) has agreed a deal to supply cannabidiol to a group developing CBD-infused wound dressings. Under the two-year agreement it will provide the hemp-derived ingredient to Cellulac, a company 9.35% owned by AIM-listed Integumen PLC (LON:SKIN). It will then be used in the Wound pHase and STOER range of wound care and skin care products.

AppScatter Group PLC (LON:APPS) has alerted shareholders to a partnership deal announced by Airpush, the company it is in the process of acquiring.

Power Metal Resources PLC (LON:POW) has taken an option over 70% of a licence to the north and east of the Tondo cobalt-copper mine in the DRC.

Kavango Resources PLC (LON:KAV) gave investors confirmed details from recent drilling at the Ditau project, following the receipt of check assay results.

Stobart Group Ltd (LON:STOB) has appointed UBS Investment Bank as its financial adviser with immediate effect.

Red Rock Resources PLC (LON:RRR) has flagged up strong results from investee company, Jupiter Mines Ltd, an Australian-listed miner that owns nearly 50% of the Tshipi Borwa open pit manganese mine in South Africa.
