"The dividend we declared this week was 1.625p so we're in line with our full year target of 6.50p".

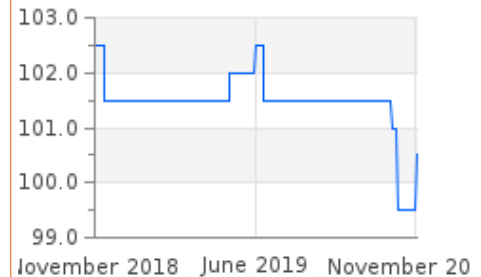
"The pipeline's building really well .. we said earlier in the year that the summer period for us was not about raising more capital it was really about making the capital that we already have work harder".
