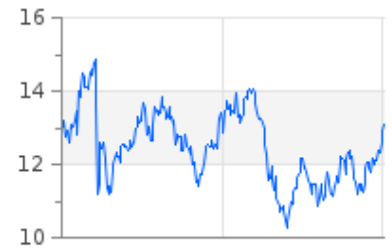
Digging deep for his weekly analysis, Mining Capital's Al Ford
