## Applied Graphene showcases its technology at prestigious industry event

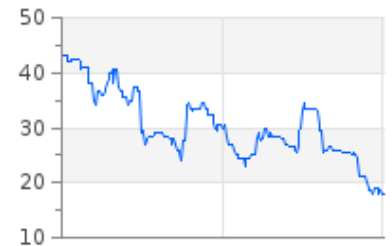
