## Bryah Resources identifies more manganese at Brumby Creek in Bryah Basin

Bryah Resources Ltd (ASX:BYH) managing director Neil Marston updates Proactive Investors on the identification of further manganese mineralisation at Brumby Creek prospect within the flagship Bryah Basin project in WA.

The managing director says assay results from the second phase of exploration drilling were extremely encouraging with zones of manganese mineralisation extended to the west of the prospect and new areas identified up to 1-kilometre along strike to the south.

A total of 83 holes for 2,081 metres of reverse circulation drilling was completed in this second program at four sites.

The company will also undertake more drilling at the nearby Black Hill prospect.
