Europa Oil & Gas (Holdings) PLC (LON:EOG) has been awarded a 15-year frontier exploration licence for an area in the Slyne Basin, offshore Ireland.

Feedback PLC (LON:FDBK) has confirmed online speculation that it is considering an equity raise to fund the development of its clinical message app, Bleepa.

W Resources PLC's (LON:WRES) is getting to the closing stages of construction at the La Parrilla mine in Spain, says chairman Michael Masterman.

Shanta Gold Limited (LON:SHG) has arranged a US\$10m loan to help develop the Singida gold deposit in Tanzania.

Shield Therapeutics PLC (LON:STX) said it hopes to have chosen a US commercial partner for its breakthrough iron deficiency drug by the end of the year.

Internet domain seller CentralNic Group PLC (LON:CNIC) has acquired Ideegeo Group, a privately owned domain name retailer based in New Zealand.

Advanced Oncotherapy PLC (LON:AVO) said it had secured £18.4m of additional funding as it heads into the fit-out stage for its state-of-the-art proton beam therapy centre on London's Harley Street.

Amur Minerals Corporation (LON:AMC) has appointed Tom Bowens as a non-executive director. Bowens is the President and CEO of IG Copper, a company he founded in 2009 and that sold the Malmyzh copper-gold project to Russian Copper for US\$200m last year.

Afarak Group PLC (LON:AFRK) has warned that second quarter earnings will be weaker than previously expected due to challenges at its Mogale smelter in South Africa but it is working on addressing the issues.
