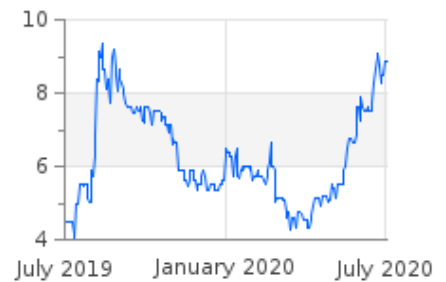
He says the big focus for the firm now is taking Sanankoro into development.
